The Company announces that on 27 April 2016 it purchased 62,946 ordinary shares of 10 pence each at a price of 57.63 pence per share. These shares will be held in treasury.

If these shares had been purchased prior to the quarter ended 31 December 2015 and on the assumption that there were no other alterations, the unaudited net asset value per ordinary share of the Company at that date would have been unaltered at 62.9 pence per ordinary share.

The Company's issued share capital now consists of 92,808,974 ordinary shares of 10 pence each with voting rights. In addition, the Company now holds 2,265,313 ordinary shares of 10 pence each in treasury.
