The Company announces that on 26 September 2024 it purchased 1,422,727 ordinary shares of 10 pence each at a price of 55.13 pence per ordinary share including transaction costs. The shares purchased represent 0.50 per cent of the total number of voting rights in the Company before the transaction. These shares will be held in treasury.

The last reported net asset value as at 30 June 2024 was 57.50 pence per ordinary share.

The Company’s issued share capital now consists of 281,977,656 ordinary shares of 10 pence each with voting rights. In addition, the Company holds 26,573,146 ordinary shares of 10 pence each in treasury.

The above figure of 281,977,656 ordinary shares may be used by shareholders as the denominator for the calculations by which they will determine if they are required to notify their interest in, or a change to their interest in, the Company under the FCA’s Disclosure and Transparency Rules.
